STEWARDS' RULING**

TURF PARADISE: 2016-2017 MEETING

Under the authority granted by Arizona Revised Statutes Title 5, Chapter 1, and Arizona Administrative Code Title 19, Chapter 2, the Board of Stewards at TURF PARADISE, located at 1501 W. Bell Road, Phoenix, 85023, held a hearing on Saturday, October 15, 2016 and issued the following Ruling:

Having been properly notified of a hearing and having waived that right, Owner-Trainer Sergio Barrio-Baray, is hereby fined ONE HUNDRED DOLLARS (\$100,00) plus 5% Race Horse Adoption Fund, for a total of ONE HUNDRED AND FIVE DOLLARS (\$105,00) for failing to properly identify the horse "FISCAL WIND" as a gelding at the time of entry.

The fine set forth above must be satisfied within ten days from the date of this order. Failure to comply with all requirements of this ruling by October 25, 2016, will result in a one hundred eighty days (180) day suspension from **October 26, 2016 through and inclusive of April 13, 2017**, and will be referred to the Director of the Arizona Department of Racing with the recommendation that his license remain suspended until such time that the financial obligation is satisfied.

The fine set forth above constitutes a violation in accordance with::
