**TURF PARADISE: 2016-2017 MEETING**

Under the authority granted by Arizona Revised Statutes Title 5, Chapter 1, and Arizona Administrative Code Title 19, Chapter 2, the Board of Stewards at TURF.PARADISE, located at 1501 W. Bell Road, Phoenix, 85023, held a hearing on Saturday, October 29, 2016 and issued the following Ruling:

**TREASURE, PAUL**

Having been properly notified for a formal hearing and having waived that right, Owner/Trainer Paul Treasure (ADOR License #19164) is hereby fined ONE HUNDRED DOLLARS (\$100.00) plus 5% to the Race Horse Adoption Fund for a total of ONE HUNDRED AND FIVE DOLLARS (\$105.00) For failing to have the foal certificate papers on file for the horse "MAJESTIC C" for the sixth race on October 29, 2016, resulting in a late scratch.

The fine set forth herein must be satisfied within ten days from the date of this order. If it is not paid by November 9, 2016, all licenses held by the respondent are automatically suspended and made ineligible for licensing in any capacity for one hundred and eighty days beginning November 10, 2016 through and inclusive May 9, 2017 and this matter is referred to the Director of the Arizona Department of Racing with the recommendation that all licenses remain suspended until all requirements herein are satisfied.
