STEWARDS' RULING**

TURF PARADISE: 2016-2017 MEETING

Under the authority granted by Arizona Revised Statutes Title 5, Chapter 1, and Arizona Administrative Code Title 19, Chapter 2, the Board of Stewards at TURF PARADISE, located at 1501 W. Bell Road, Phoenix, 85023, held a hearing on Monday, October 31, 2016 and issued the following Ruling:

Having been properly noticed to a formal hearing, and having waived that right on October 31, 2016, Jockey Larren Stephen Delorme (ADOR #20941) is hereby fined ONE HUNDRED DOLLARS (\$100.00) plus 5% Race Horse Adoption surcharge for a total of ONE HUNDRED AND FIVE DOLLARS (\$105.00) for failing to attend films on October 30, 2016, as instructed by the Board of Stewards.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by November 11, 2016, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning November 12, 2016, through and inclusive of May 11, 2017, and this matter is referred to the Director of the Arizona Department of Racing with the recommendation that all licenses remain suspended until all requirements herein are satisfied.
