**TURF PARADISE: 2016-2017 MEETING**

Under the authority granted by Arizona Revised Statutes Title 5, Chapter 1, and Arizona Administrative Code Title 19, Chapter 2, the Board of Stewards at TURF PARADISE, located at 1501 W. Bell Road, Phoenix, 85023, held a hearing on Tuesday, November 15, 2016 and issued the following Ruling:

Having been properly notified for a hearing, and having waived that right on November 15, 2016, Owner/Trainer Robertino Diodoro (ADOR #10970) is hereby fined ONE HUNDRED DOLLARS (\$100.00) plus 5% Race Horse Adoption surcharge for a total of ONE HUNDRED AND FIVE DOLLARS (\$105.00), for failing to identify the horse ONE FOR MY BABY as a gelding at the time of entry.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by November 25, 2016, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning November 26, 2016 through and inclusive of May 25, 2017, and this matter is referred to the Director of the Arizona Department of Racing with the recommendation that all licenses remain suspended until all requirements herein are satisfied.

The above described matter constitutes a violation in accordance with:
