STEWARDS' RULING**

TURF PARADISE: 2017-2018 MEETING

Under the authority granted by Arizona Revised Statutes Title 5, Chapter 1, and Arizona Administrative Code Title 19, Chapter 2, the Board of Stewards at TURF PARADISE, located at 1501 W. Bell Road, Phoenix, 85023, held a hearing on Tuesday, November 14, 2017 and issued the following Ruling:

Having been properly noticed for a formal hearing and having waived that right on November 14, 2017, Jockey Emilio Salazar-Tapia (ADG #10921) is hereby fined ONE HUNDRED DOLLARS (\$100.00) plus 5% Race Horse Adoption Fund surcharge for a total of ONE HUNDRED AND FIVE DOLLARS (\$105.00) for failure to fulfill his riding engagements on November 06, 2017 at Turf Paradise Race Course.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by November 24, 2017, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning November 25, 2017 through and inclusive of May 24, 2018, and this matter is referred to the Director of the Arizona Department of Racing with the recommendation that all licenses remain suspended until all requirements herein are satisfied.

The above described matter constitutes a violation in accordance with:
A.A.C. R19-2-106.C.; A.A.C. R19-2-109.2.; A.A.C. R19-2-121.E.2.

The Director may sustain, reverse, or modify any decision of the Stewards and may sustain, increase or decrease any penalty imposed by the Stewards.
