TURF PARADISE: 2017-2018 MEETING

Under the authority granted by Arizona Revised Statutes Title 5, Chapter 1, and Arizona Administrative Code Title 19, Chapter 2, the Board of Stewards at TURF PARADISE, located at 1501 W. Bell Road, Phoenix, 85023, held a hearing on Saturday, December 30, 2017 and issued the following Ruling:




Having been properly noticed for to a formal hearing and having waived that right on December 26, 2017, Trainer Rigoberto Guillen (ADG #10890) is hereby fined the sum of ONE HUNDRED DOLLARS (\$100.00) plus 5% Race Horse Adoption surcharge for a total of ONE HUNDRED AND FIVE DOLLARS (\$105.00) for failing to honor the entry of the horse "TRULY UNUSUAL" in the fifth race on December 27, 2017, resulting in a late scratch at Turf Paradise Race Course.

The fine set forth above must be satisfied within ten days from the date of this order. Failure to comply with all requirements of this ruling by January 09, 2018, will result in a one hundred eighty days (180) day suspension from (January 10, 2018 through and including June 28, 2018) and will be referred to the Director of the Arizona Department of Gaming - Racing Division with the recommendation that his license remain suspended until such time that the financial obligation is satisfied.

The above described matter constitutes a violation in accordance with:

This ruling may be appealed in writing to the Director, Arizona Department of Gaming - Racing Division within three race days from the date of the receipt of this Stewards' ruling. The Director may sustain, reverse, or modify any decision of the Stewards and may sustain, increase or decrease any penalty imposed by the Stewards.
