TURF PARADISE: 2017-2018 MEETING

Under the authority granted by Arizona Revised Statutes Title 5, Chapter 1, and Arizona Administrative Code Title 19, Chapter 2, the Board of Stewards at TURF PARADISE, located at 1501 W. Bell Road, Phoenix, 85023, held a hearing on Monday, February 05, 2018 and issued the following Ruling:




Having been properly noticed for to a formal hearing and having waived that right on February 3, 2018, Jockey Richard Lull (ADG #20107) is hereby fined the sum of ONE HUNDRED DOLLARS (\$100.00) plus 5% Race Horse Adoption surcharge for a total of ONE HUNDRED AND FIVE DOLLARS (\$105.00) for failing to honor the entry of the horse "IMROCKINGTHISLIFE" in the fifth race on January 30, 2018, at Turf Paradise Race Course.

The fine set forth above must be satisfied within ten days from the date of this order. Failure to comply with all requirements of this ruling by February 16, 2018, will result in a one hundred eighty days (180) day suspension from (February 17, 2018 through and including August 16, 2018) and will be referred to the Director of the Arizona Department of Gaming - Racing Division with the recommendation that his license remain suspended until such time that the financial obligation is satisfied.

The above described matter constitutes a violation in accordance with:

A.A.C. R19-2-106(C), R19-2-109(E), R19-2-111(A), R19-2-111(B), R19-2-112(12), R19-2-121(E).
