STEWARDS' RULING**

TURF PARADISE: 2017-2018 MEETING

Under the authority granted by Arizona Revised Statutes Title 5, Chapter 1, and Arizona Administrative Code Title 19, Chapter 2, the Board of Stewards at TURF PARADISE, located at 1501 W. Bell Road, Phoenix, 85023, held a hearing on Saturday, April 07, 2018 and issued the following Ruling:

Having been properly noticed for a formal hearing and having waived that right on April 7, 2018, Owner/Trainer Guillermo Morales (ADG #18662) is hereby fined ONE HUNDRED (\$100.00) plus 5% Race Horse Adoption Fund surcharge for a total of ONE HUNDRED FIVE DOLLARS (\$105.00) for failing to have the owner of the horse "KISS MY EAGLE" properly licensed resulting in a late scratch in the 3rd race on April 7, 2018 at Turf Paradise Racetrack.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by April 18, 2018, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning April 19, 2018 through and inclusive of October 16, 2018, and this matter is referred to the Director of the Arizona Division of Racing with the recommendation that all licenses remain suspended until all requirements herein are satisfied.
