**NOTICE OF APPEAL HEARING**

YOU ARE HEREBY NOTIFIED that, pursuant to Arizona Administrative Code (“A.A.C.”) R19-2-123(A)(4), the Director of the Division of Racing (“Director”) has decided that a hearing is appropriate in this matter. The Director will conduct a hearing at 10:00 a.m., Friday, July 7, 2017. The hearing will take place in the conference room of the Arizona Department of Gaming located at 1110 W. Washington Street, Suite 450, Phoenix, Arizona.

The purpose of the hearing is to address your appeal filed on or about May 22, 2017, and pursuant to A.A.C. R19-2-123(A)(1), seeking review by the Director of the decision of the Sonoita Board of Stewards that “there was insufficient evidence to support your claim that the #8 Black Ops should be disqualified for interference” against your horse, the #6 “VOLCANO” in the 7<sup>th</sup> race on May 7, 2017 at Sonoita Race Track.

You may appear with or without the assistance of an attorney on the date and at the time and place specified in this Notice of Hearing. You may present testimony and argument in support of your appeal. At the hearing, you will have the burden of proof with respect to your claim that the Stewards ruling was incorrect.

**YOU ARE FURTHER NOTIFIED** that if you fail to appear, the Director may proceed and determine the matter in your absence pursuant to A.A.C. R19-2-123(D)(2).

Pursuant to A.R.S. § 41-1092.06(A), you have the right to request an informal settlement conference by filing a written request with the Board no later than twenty (20) days before the scheduled hearing. The conference will be held within fifteen (15) days after receipt

1 of your request. Please note that you waive any right to object to the participation of the  
2 Board's representative in the final administrative decision of the matter if it is not settled at the  
3 conference.

4 In accordance with Title II of the Americans with Disabilities Act (ADA), the  
5 Department does not discriminate on the basis of disability in admission to and participation in  
6 hearings. Should you, or anyone you call as a witness need special accommodations, please
