**TURF PARADISE: 2018-2019 MEETING**

Under the authority granted by Arizona Revised Statutes Title 5, Chapter 1, and Arizona Administrative Code Title 19, Chapter 2, the Board of Stewards at TURF PARADISE, located at 1501 W. Bell Road, Phoenix, 85023, held a hearing on Monday, October 15, 2018 and issued the following Ruling:




Having been properly noticed for a formal hearing and having waived that right on October 15, 2018, Owner/Trainer Pedro Urias-Soto (ADG #11503) is hereby fined TWO HUNDRED (\$200.00) plus 5% Race Horse Adoption Fund surcharge for a total of TWO HUNDRED AND TEN (\$210.00) for failing to show up to the paddock with the horse "KODIANNE", resulting in a late scratch in the 6th race on October 14, 2018.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by October 26, 2018, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning October 27, 2018 through and inclusive of April 24, 2019, and this matter is referred to the Director of the Arizona Department of Racing with the recommendation that all licenses remain suspended until all requirements herein are satisfied.

The above described matter constitutes a violation in accordance with:  
A.A.C. R19-2-106(C) ; A.A.C. R19-2-111.; A.A.C. R19-2-113(A)(6)(18); A.A.C. R19-2-121.

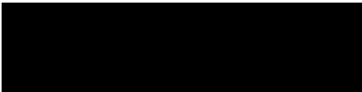
**BY ORDER OF THE STEWARDS**

The Director may sustain, reverse, or modify any decision of the Stewards and may sustain, increase or decrease any penalty imposed by the Stewards.
