Under the authority granted by Arizona Revised Statutes Title 5, Chapter 1, and Arizona Administrative Code Title 19, Chapter 2, the Board of Stewards at TURF PARADISE, located at 1501 W. Bell Road, Phoenix, 85023, held a hearing on Tuesday, November 06, 2018 and issued the following Ruling:

Having been properly notified of a formal hearing and having failed to appear, Jockey Jose Francisco Arriola Serrano (ADOR #21841) is hereby fined FIFTY DOLLARS (\$50.00) plus 5% Race Horse Adoption surcharge for a total FIFTY TWO DOLLARS AND FIFTY CENTS (\$52.50) For failing to attend films on November 4, 2018, as instructed by the Board of Stewards.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by November 16, 2018, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning November 17, 2018 through and inclusive of May 16, 2019, and this matter is referred to the Director of the Arizona Department of Racing with the recommendation that all licenses remain suspended until all requirements herein are satisfied.
