**TURF PARADISE: 2018-2019 MEETING**

Under the authority granted by Arizona Revised Statutes Title 5, Chapter 1, and Arizona Administrative Code Title 19, Chapter 2, the Board of Stewards at TURF PARADISE, located at 1501 W. Bell Road, Phoenix, 85023, held a hearing on Wednesday, November 07, 2018 and issued the following Ruling:

Having been properly noticed for a formal hearing and having waived that right on November 7, 2018, Trainer Marjorie Ann Cantrell (ADG #22364) is hereby fined ONE HUNDRED DOLLARS (\$100.00) plus 5% Race Horse Adoption Fund surcharge for a total of ONE HUNDRED AND FIVE (\$105.00) for being late to the paddock with the horse "Canada" for the 8th race on November 5, 2018 necessitating a late scratch.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by November 13, 2018, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning November 14, 2018 through and inclusive of May 13, 2019, and this matter is referred to the Director of the Arizona Department of Racing with the recommendation that all licenses remain suspended until all requirements herein are satisfied.

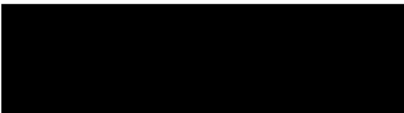
