STEWARDS' RULING**

TURF PARADISE: 2018-2019 MEETING

Under the authority granted by Arizona Revised Statutes Title 5, Chapter 1, and Arizona Administrative Code Title 19, Chapter 2, the Board of Stewards at TURF PARADISE, located at 1501 W. Bell Road, Phoenix, 85023, held a hearing on Sunday, November 11, 2018 and issued the following Ruling:

Having been properly noticed for a formal hearing and having waived that right on November 7, 2018, Trainer Rudy Ybarra (ADG #12700) is hereby fined ONE HUNDRED DOLLARS (\$100.00) plus 5% Race Horse Adoption Fund surcharge for a total of ONE HUNDRED AND FIVE DOLLARS (\$105.00) for having missed Lasix with the horse "HEY EZ MONEY", resulting in a late scratch in the 3rd race on November 5, 2018.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by November 21, 2018, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning November 22, 2018 through and inclusive of May 21, 2019, and this matter is referred to the Director of the Arizona Department of Racing with the recommendation that all licenses remain suspended until all requirements are satisfied.
