STEWARDS' RULING**

TURF PARADISE: 2018-2019 MEETING

Under the authority granted by Arizona Revised Statutes Title 5, Chapter 1, and Arizona Administrative Code Title 19, Chapter 2, the Board of Stewards at TURF PARADISE, located at 1501 W. Bell Road, Phoenix, 85023, held a hearing on Sunday, November 18, 2018 and issued the following Ruling:

Having been properly noticed for a formal hearing and having appeared, Owner/Trainer Daniel Joseph O'Brien (ADOR # 10804) is hereby fined ONE HUNDRED DOLLARS (\$100.00) plus 5% Race Horse Adoption Fund surcharge for a total of ONE HUNDRED AND FIVE DOLLARS (\$105.00) for failing to honor the entry of the horse "BON" for the sixth race on November 17, 2018, resulting in a late scratch.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by November 28, 2018, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning November 29, 2018, through and inclusive of May 28, 2019, and this matter is referred to the Director of the Arizona Department of Racing with the recommendation that all licenses remain suspended until all requirements herein are satisfied.

The above described matter constitutes a violation in accordance with:

A.A.C. R19-2-106(C); A.A.C. R19-2-109(2); A.A.C. R19-2-121(E)

The Director may sustain, reverse, or modify any decision of the Stewards and may sustain, increase or decrease any penalty imposed by the Stewards.
