STEWARDS' RULING**

TURF PARADISE: 2018-2019 MEETING

Under the authority granted by Arizona Revised Statutes Title 5, Chapter 1, and Arizona Administrative Code Title 19, Chapter 2, the Board of Stewards at TURF PARADISE, located at 1501 W. Bell Road, Phoenix, 85023, held a hearing on Tuesday, December 04, 2018 and issued the following Ruling:

Having been properly notified for a hearing and having waived that right, Jockey Rigo Sarmiento (ADG #24007) is hereby fined TWO HUNDRED FIFTY DOLLARS (\$250.00) plus 5% Race Horse Adoption Fund for a total of TWO HUNDRED AND SIXTY TWO DOLLARS AND FIFTY CENTS (\$262.50) for failing to ride his mount out to wire in the seventh race on December 2, 2018, at Turf Paradise Race Course, costing his mount "CRUMLIN DIVA" a position.

The fine set forth herein must be satisfied within ten days from the date of this order. If it is not paid by December 14, 2018, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning December 15, 2018, through and inclusive of June 13, 2019, and this matter is referred to the Director of the Arizona Department of Racing with the recommendation that all licenses remain suspended until all requirements herein are satisfied.

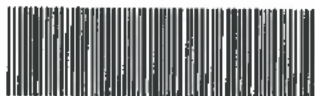
