STEWARDS' RULING**

TURF PARADISE: 2018-2019 MEETING

Under the authority granted by Arizona Revised Statutes Title 5, Chapter 1, and Arizona Administrative Code Title 19, Chapter 2, the Board of Stewards at TURF PARADISE, located at 1501 W. Bell Road, Phoenix, 85023, held a hearing on Tuesday, December 11, 2018 and issued the following Ruling:

Having been properly notified for a hearing and having failed to appear, Keaton Hopp (ADG #23862) is hereby fined TWO HUNDRED DOLLARS (\$200.00) plus 5% Race Horse Adoption surcharge for a total of TWO HUNDRED AND TEN DOLLARS (\$210.00), for falsification of your license by failing to disclose his entire criminal record.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by December 21, 2018, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning December 22, 2018 through and inclusive of June 20, 2019, and this matter is referred to the Director of the Arizona Department of Racing with the recommendation that all licenses remain suspended until all requirements herein are satisfied.

The above described matter constitutes a violation in accordance with:
A.A.C. R-19-2-106(B)(C); A.A.C. R-19-2-121(E); A.R.S. 5-104(B); A.R.S. 5-108(A);
