STEWARDS' RULING

TURF PARADISE: 2018-2019 MEETING

Under the authority granted by Arizona Revised Statutes Title 5, Chapter 1, and Arizona Administrative Code Title 19, Chapter 2, the Board of Stewards at TURF PARADISE, located at 1501 W. Bell Road, Phoenix, 85023, held a hearing on Tuesday, January 15, 2019 and issued the following Ruling:

Having been properly notified for a hearing and having failed to appear, Groom Anthony Wayne Baer (ADG# 24165) is hereby fined TWO HUNDRED DOLLARS (\$200.00) plus 5% Race Horse Adoption surcharge for a total of TWO HUNDRED AND TEN DOLLARS (\$210.00), for falsification of your license by failing to disclose his criminal record.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by January 26, 2019, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning January 27, 2019, through and inclusive of July 26, 2019, and this matter is referred to the Director of the Arizona Department of Racing with the recommendation that all licenses remain suspended until all requirements herein are satisfied. The above described matter constitutes a violation in accordance with:

A.A.C. R-19-2-106(B)(C); A.A.C. R-19-2-121(E); A.R.S. 5-104(B); A.R.S. 5-108(A);

BY ORDER OF THE STEWARDS

Pursuant to Arizona Racing Commission rules and regulations, the Stewards shall advise the Director of all hearings and rulings made. The Stewards may refer any ruling made by them to the Director, recommending further actions, including license revocation. This ruling may be appealed in writing to the Director, Arizona Department of Gaming within three race days from the date of the receipt of this Stewards' ruling. The Director may sustain, reverse, or modify any decision of the Stewards and may sustain, increase or decrease any penalty imposed by the Stewards.
