TURF PARADISE: 2018-2019 MEETING

Under the authority granted by Arizona Revised Statutes Title 5, Chapter 1, and Arizona Administrative Code Title 19, Chapter 2, the Board of Stewards at TURF PARADISE, located at 1501 W. Bell Road, Phoenix, 85023, held a hearing on Tuesday, February 26, 2019 and issued the following Ruling:

Having been properly noticed for a formal hearing and having waived that right on February 26, 2019, Trainer Eloy Gerado Navarro (ADG #11969) is hereby fined TWO HUNDRED (\$200.00) plus 5% Race Horse Adoption Fund surcharge for a total of TWO HUNDRED AND TEN DOLLARS (\$210.00) for the unauthorized scratch of the horse "HIGHER ICON", in the first race on February 26, 2019.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by March 9, 2019, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning March 10, 2019, through and inclusive of September 6, 2019, and this matter is referred to the Director of the Arizona Department of Gaming/Racing Division with the recommendation that all licenses remain suspended until all requirements herein are satisfied.
