STEWARDS' RULING**

TURF PARADISE: 2018-2019 MEETING

Under the authority granted by Arizona Revised Statutes Title 5, Chapter 1, and Arizona Administrative Code Title 19, Chapter 2, the Board of Stewards at TURF PARADISE, located at 1501 W. Bell Road, Phoenix, 85023, held a hearing on Saturday, April 06, 2019 and issued the following Ruling:

Having been properly noticed for a formal hearing and having waived that right, Owner/Trainer Monica Ortega (ADG#11803) is hereby fined THREE HUNDRED DOLLARS (\$300.00) plus 5% Race Horse Adoption Fund surcharge for a total of THREE HUNDRED AND FIFTEEN DOLLARS (\$315.00) For failing to ensure that the horses (Creative Doux, French General, and Fly Papa Fly) had valid health certificates on file with the Racing Secretary on Tuesday, April 2, 2019 at Turf Paradise Race Course, resulting in their being scratched.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by April 16, 2019, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning April 17, 2019, through and inclusive of October 14, 2019, and this matter is referred to the Director of the Arizona Department of Racing with the recommendation that all licenses remain suspended until all requirements herein are satisfied.

The above described matter constitutes a violation in accordance with:

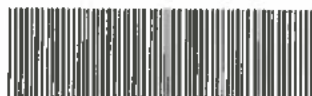
