TURF PARADISE: 2018-2019 MEETING

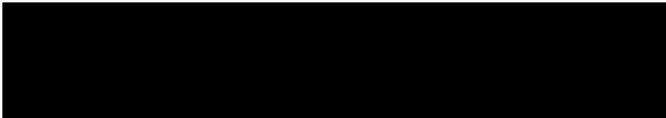
Under the authority granted by Arizona Revised Statutes Title 5, Chapter 1, and Arizona Administrative Code Title 19, Chapter 2, the Board of Stewards at TURF PARADISE, located at 1501 W. Bell Road, Phoenix, 85023, held a hearing on Sunday, April 07, 2019 and issued the following Ruling:

Having been properly notified for a hearing, and having waived that right on April 7, 2019, Owner/Trainer Armando Castellanos-Loza (ADG #10024) is hereby fined ONE HUNDRED DOLLARS (\$100.00) plus 5% Race Horse Adoption surcharge for a total of ONE HUNDRED AND FIVE DOLLARS (\$105.00), for failing to identify the horse "DETERMINED COWBOY" as a gelding at the time of entry in the first race on April 7, 2019.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by April 17, 2019, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning April 18, 2019, through and inclusive of October 15, 2019, and this matter is referred to the Director of the Arizona Department of Racing with the recommendation that all licenses remain suspended until all requirements herein are satisfied.

The above described matter constitutes a violation in accordance with:
