STEWARDS' RULING**

TURF PARADISE: 2018-2019 MEETING

Under the authority granted by Arizona Revised Statutes Title 5, Chapter 1, and Arizona Administrative Code Title 19, Chapter 2, the Board of Stewards at TURF PARADISE, located at 1501 W. Bell Road, Phoenix, 85023, held a hearing on Sunday, May 05, 2019 and issued the following Ruling:

PEARSON-ANDERSON, MOLLY JEAN

Having been properly noticed for a formal hearing and having waived that right on May 4, 2019, Owner/Trainer Molly Pearson (ADG #10824) is hereby fined TWO HUNDRED (\$200.00) plus 5% Race Horse Adoption Fund surcharge for a total of TWO HUNDRED AND TEN (\$210.00) for failing to honor the engagement with the horse "BOURBON AND WATER", resulting in a late scratch in the 2nd race on May 4, 2019.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by May 15, 2019, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning May 16, 2019 through and inclusive of November 12, 2019, and this matter is referred to the Director of the Arizona Department of Racing with the recommendation that all licenses remain suspended until all requirements herein are satisfied.

The above described matter constitutes a violation in accordance with:
A.A.C. R19-2-106(C) ; A.A.C. R19-2-111.; A.A.C. R19-2-113(A)(6)(18); A.A.C. R19-2-121.

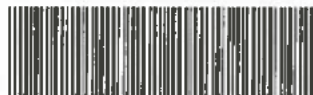
