TURF PARADISE: 2019-2020 MEETING

Under the authority granted by Arizona Revised Statutes Title 5, Chapter 1, and Arizona Administrative Code Title 19, Chapter 2, the Board of Stewards at TURF PARADISE, located at 1501 W. Bell Road, Phoenix, 85023, held a hearing on Friday, September 13, 2019 and issued the following Ruling:

Having been properly noticed for a formal hearing and having appeared, Owner/Trainer Eloy Navarro (ADG #11969) is hereby fined ONE THOUSAND DOLLARS (\$1,000.00) plus 5% Race Horse Adoption Fund surcharge for a total of ONE THOUSAND FIFTY DOLLARS (\$1,050.00) and suspended THIRTY CALENDAR DAYS, (30) (October 12, 2019, through November 10, 2019, inclusive), after receipt of an affidavit from Industrial Laboratories indicating blood/urine sample #E307142 taken from the horse "IM ROCKET MAN", second (2nd) place finisher in the seventh (7th) race on August 18, 2019, at Arizona Downs was confirmed positive for the presence of the Class III foreign substance CLENBUTEROL at a concentration of approximately 24.4 pg/ml.

The horse "IM ROCKET MAN", second (2nd) place finisher in the seventh (7th) race on August 18, 2019, shall be disqualified and declared unplaced. Additionally "IM ROCKET MAN", shall be placed on the Stewards List from September 13, 2019 through and inclusive of November 11, 2019, (60 days) and must be retested (negative sample) for foreign substances prior to removal from the Stewards List.

The horsemen's bookkeeper is hereby directed to make the necessary changes. This action does not alter the Pari- Mutuel results of the race in question.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by September 23, 2019, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning September 24, 2019, through and inclusive of March 22, 2019, and this matter is referred to the Director of the Arizona Department of Gaming/Racing Division with the recommendation that all licenses remain suspended until all requirements herein are satisfied.

During the term of his suspension Eloy Navarro is denied access to all grounds under the jurisdiction of the Arizona Department of Gaming/Racing Division. All horses owned and/or trained by the respondent are hereby denied entry for racing pending sale and/or transfer approved by the Board of Stewards.
