Having been properly noticed for a formal hearing and having waived that right on October 22, 2016, Jockey Scott Allen Stevens (ADOR #10976) is hereby suspended three (3) racing days (October 29, 30, and 31, 2016 inclusive) for causing interference in the stretch in the seventh race on October 17, 2016, resulting in the disqualification of his mount I'VEGOTAFEELING from fourth to fifth position

This suspension does not preclude Jockey Scott Allen Stevens from riding in designated races.

Having been properly notified for a hearing, and having waived that right on October 25, 2016, Trainer Osvaldo Apodaca Esparza (ADOR #14216) is hereby fined ONE HUNDRED DOLLARS (\$100.00) plus 5% Race Horse Adoption surcharge for a total of ONE HUNDRED AND FIVE DOLLARS (\$105.00), for conducting business in an improper manner, causing a late scratch in the eighth race on October 23, 2016.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by November 6, 2016, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning November 7, 2016 through and inclusive of May 6, 2017, and this matter is referred to the Director of the Arizona Department of Racing with the recommendation that all licenses remain suspended until all requirements herein are satisfied.

Having been properly notified for a formal hearing and having waived that right on October 24, 2016, Owner/Trainer Victor Dustin T. Murray (ADOR License #15147) is hereby fined ONE HUNDRED DOLLARS (\$100.00) plus 5% to the Race Horse Adoption Fund for a total of ONE HUNDRED AND FIVE DOLLARS (\$105.00) For being subject or permitting a horse under his control to be deprived of necessary care and sustenance.

The fine set forth herein must be satisfied within ten days from the date of this order. If it is not paid by November 3, 2016, all licenses held by the respondent are automatically suspended and made ineligible for licensing in any capacity for one hundred and eighty days beginning November 4, 2016 through May 3, 2017, and this matter is referred to the Director of the Arizona Department of Racing with the recommendation that all licenses remain suspended until all requirements herein are satisfied.
