Following a formal telephone hearing on October 29, 2016, the Owner's license of George Sainz is hereby revoked for failing to disclose his entire criminal history in his license application.

All horses owned by the respondent, are hereby suspended from entry to race, pending a bona fide sale and transfer.

Further, George Sainz is hereby denied access to all grounds under the jurisdiction of the Arizona Department of Gaming.

TURF PARADISE RULING #16-17TP019

Having been properly notified for a formal hearing and having waived that right via telephone on October 30, 2016, Owner/Trainer Juan Francisco Figueroa (ADOR License #10089) is hereby fined FIVE HUNDRED DOLLARS (\$500.00) plus 5% to the Race Horse Adoption Fund for a total of FIVE HUNDRED AND TWENTY FIVE DOLLARS (\$525.00) and suspended fifteen calendar days (October 31 through November 14, 2016), after receipt of an affidavit indicating blood sample #E194001 taken from the horse "K KARDASHIAN," winner of the first race on October 15, 2016, was confirmed positive for the presence of the Class III foreign substance CLENBUTEROL (4 pg/mL).

The fine set forth herein must be satisfied within ten days from the date of this order. If it is not paid by November 10, 2016, all licenses held by the respondent are automatically suspended and made ineligible for licensing in any capacity for one hundred and eighty days beginning November 11, 2016, through May 10, 2017, and this matter is referred to the Director of the Arizona Department of Racing with the recommendation that all licenses remain suspended until all requirements herein are satisfied.

During the term of his suspension, Juan Francisco Figueroa is denied access to all grounds under the jurisdiction of the Arizona Department of Gaming. All horses owned and/or trained by the respondent are denied entry for racing pending sale and/or transfer approved by the Board of Stewards.

The horse "K KARDASHIAN", winner of the first race on October 15, 2016, at Turf Paradise Race Course is hereby disqualified and declared unplaced. The revised order of finish is as follows:
