Having been properly noticed for a formal hearing, and having appeared, Trainer Mario Jimenez Loza (ADOR License #20335) is hereby fined FIVE HUNDRED DOLLARS (\$500.00) plus 5% Race Horse Adoption Fund for a total of FIVE HUNDRED AND TWENTY DOLLARS (\$525.00.), and suspended FIFTEEN (15) CALENDAR DAYS (November 21, 2016, through and inclusive of December 5, 2016), after receipt of a split sample report from PA Equine Medication Toxicology & Research Laboratory confirming the presence of Clenbuterol, at a concentration of 2.5+/- 0.08 pg/mL in blood sample #E194029, collected from the horse "ONE SWEET BULLET," winner of the first race on October 16, 2016, at Turf Paradise Race Course. Furthermore, the horse "ONE SWEET BULLET" is placed on the Stewards' List pending a negative blood sample for Clenbuterol.

The fine set forth herein must be satisfied within ten days from the date of this order. If it is not paid by November 30, 2016, all licenses held by the respondent are automatically suspended and made ineligible for licensing in any capacity for one hundred and eighty days beginning December 1, 2016 through and inclusive of May 30, 2017, inclusive, and this matter is referred to the Director of the Arizona Department of Gaming/ Racing Division with the recommendation that all licenses remain suspended until all requirements herein are satisfied.
