Significant Incidents /Matters:

Race 1: #6 SEA HORSE RUN raced with blinkers on.

Race 2: #2 NIGHTHAWK SPECIAL bore out badly and was placed on the steward's list.

Race 3: #1 PARLAY PONTI raced with blinkers off. #3 LOOKING FOR INFO raced with blinkers on. #3 LOOKING FOR INFO bled post-race. #5 MONKEYWITHAMUSKET was eased and placed on the steward's list.

Race 4: Due to a program error, the #1 and #4 horses were listed as scratched in all advanced deposit wagering sites. Due to this error and in conjunction with track management, the decision was made to run this race for purse money only as there was no way to correct the error in an equitable fashion. #6 BADLY NEEDED was determined to be lame post-race and was placed on the veterinarian's list.


Race 5: None.

Race 6: #2 DANGEROUSLY SWIFT ownership change to LONNY OLIVER, trainer changed to RUDY YBARRA. #6 BIG WAVE BETTY the jockey lost the irons shortly after the start and was observed to have bled by the track veterinarian post-race and was placed on the bleeder's list.

Race 7: The trainer of #8 FORREST SMOKE lodged and objection against the #7 DOS TOCALLOS alleging interference at the start. After reviewing the videotape, the steward's upheld the claim of foul. The #7 DOS TOCALLOS stumbled badly after the start and impeded the path of the #8 FORREST SMOKE and was disqualified and placed 7th.

Race 8: #1 EL MARTILLITO and #2 DOG CHOICE raced with blinkers. #2 DOG CHOICE was reluctant to load and escaped the outrider and ran loose. After track veterinarian examination the horse was allowed to run but was placed on the starter's list.
