Race 1: #6 COUNTLESS WAYS additional workout announced at Rillito on 2/14/19 220 yards in 12.81.

Race 2: #2 MUNDI STONE announced as a first-time gelding. **#5 BLUE GESSAMI** additional workout announced at Rillito on 2/14/19 4F :49.50. **#2 QUICK GUN** was eased and placed on the steward's list.

Race 3: #6 JILAS PRINCE additional workout announced at Rillito on 2/2/19 1F in :50.25.

Race 4: There was no show wagering. **#3 QUIET SHADOW** additional workout announced at Rillito on 2/2/19 1F yards in 13.07 out of the gate. **#3 QUIET SHADOW** raced with blinkers on and was also determined to be lame post-race and was placed on the veterinarian's list.

Race 6: None.



There was a steward's inquiry involving the start of the race with the **#7 FIRE ON DESERT**. After reviewing the videotape, it was determined the horse caused its own problem and was declared a starter for pari-mutuel purposes.

Race 8: #7 COUNT YOUR MONEY additional workout announced at Rillito on 2/3/19 3F in :37.66. **#3 QUEEN'S BAR** was observed to have bled following the race by the track veterinarian and was placed on the bleeder's list.
