Significant Incidents /Matters:

Race 1: #5 GOLDEN CHEMA raced without a flipping halter.

Race 2: #1 ICED BY PATRON was observed to have bled post-race by the track veterinarian and was placed on the bleeder's list.

Race 3: #5 HIDE YOUR KRAZY was announced as first-time Lasix. The rider of **#5 HIDE YOUR KRAZY** (ANDRES OSUNA) lodged an objection against the riders of the **#4 LONELY DESIRIO** (DAVID REYES-FRISBY) and the **#6 NICOS FAVORITECARTEL** (JUAN C. RAMIREZ) alleging interference shortly after the start. After reviewing the videotape the stewards determined that the **#6 NICOS FAVORITECARTEL** drifted in and herded the **#5 HIDE YOUR KRAZY** causing the #5 to bump the #4 and eventually taking the path away from the #5. The **#6 NICOS FAVORITECARTEL** was disqualified from 4th and placed 7th.

Race 4: None.

Race 5: The owner of the **#8 STARFACE** was changed from Victor De La Garza Salazar to Victor Paul Salazar. The **#1 LEGAL TRIBE** ducked in sharply leaving the starting gate unseating the rider and broke through the inner safety rail.


Race 6: #7 TIZIERRA was observed to have bled post-race by the track veterinarian and was placed on the bleeder's list.
