**Significant Incidents /Matters:**

**Race 1:** Stewards' Inquiry and Objection by Jockey Michael Ybarra aboard **#5 S S TAYLOR** claiming foul against **#3 MAGNIFICENT DAWN** ridden by Kenneth Deonauth for interference in the stretch. The Stewards reviewed the race replay from the head-on and pan cameras and determined the #3 Magnificent Dawn continually bore out causing the jockey of #5 S S Taylor to take hold and alter course. #3 Magnificent Dawn was disqualified from first and placed second.

**Race 3:** None.

**Race 4:** Stewards' Inquiry into stretch run and Objection by Jockey Daniel Aguilar aboard **#7 LIEUTENANT MARGIE** against **#3 HEROES FOR GHOSTS** ridden by Richard Gamez. The Stewards reviewed video replay of the head-on and pan cameras and determined that #7 Lieutenant Margie was cost the opportunity to finish higher when #3 Heroes For Ghosts bore out inside the 1/16 pole impeding and causing #5 Lieutenant Margie to be checked by the rider. #3 Heroes For Ghosts was disqualified from 2<sup>nd</sup> to 4<sup>th</sup>.


