## ARIZONA DOWNS: 2019 MEETING

Under the authority granted by Arizona Revised Statutes Title 5, Chapter 1, and Arizona Administrative Code Title 19, Chapter 2, the Board of Stewards at ARIZONA DOWNS, located at 10501 E. STATE ROUTE 89A, PRESCOTT VALLEY, held a hearing on Saturday, August 10, 2019 and issued the following Ruling:




Having been properly notified of a hearing, and having appeared, owner/trainer Brent Angelle (ADG #23968) is hereby suspended for SIXTY (60) DAYS from July 28, 2019, through and inclusive of September 28, 2019 (credited with seven days served after being summarily suspended on July 28, 2019) for testing positive for METHAMPHETAMINE. In addition, the respondent must provide a negative urine sample and sign a drug testing agreement form prior to reinstatement. If Mr. Angelle provides proof to the board of stewards that he has enrolled in a substance abuse program, he will have FIFTEEN (15) DAYS of his suspension stayed.

During the term of his suspension, owner/trainer Brent Angelle is denied access to all grounds under the jurisdiction of the Arizona Department of Gaming/Racing Division.

The above described matter constitutes a violation in accordance with:

A.A.C. R19-2-102(76); A.A.C. R19-2-106(C); A.A.C. R19-2-112(12)(13); A.A.C. R19-2-121(E); A.R.S. 5.104(C); A.R.S. 5-108(A)

BY ORDER OF THE STEWARDS

Pursuant to Arizona Racing Commission rules and regulations, the Stewards shall advise the Director of all hearings and rulings made. The Stewards may refer any ruling made by them to the Director, recommending further actions, including license revocation. This ruling may be appealed in writing to the Director, Arizona Department of Racing within three race days from the date of the receipt of this Stewards' ruling. The Director may sustain, reverse, or modify any decision of the Stewards and may sustain, increase or decrease any penalty imposed by the Stewards.
