

ARIZONA DEPARTMENT OF RACING STEWARDS' RULING

ARIZONA DOWNS: 2018 MEETING

Under the authority granted by Arizona Revised Statutes Title 5, Chapter 1, and Arizona Administrative Code Title 19, Chapter 2, the Board of Stewards at ARIZONA DOWNS, located at 10501 E. STATE ROUTE 89A, PRESCOTT VALLEY, held a hearing on Saturday, August 17, 2019 and issued the following Ruling:

Having been properly noticed for a formal hearing and having waived that right, Owner/Trainer Eloy Navarro (ADG #11969) is hereby fined FIVE HUNDRED DOLLARS (\$500.00) plus 5% Race Horse Adoption Fund surcharge for a total of FIVE HUNDRED TWENTY FIVE DOLLARS (\$525.00) and suspended FIFTEEN CALENDAR DAYS, (15) (August 19, 2019, through September 2, 2019, inclusive), after receipt of an affidavit from Industrial Laboratories indicating blood/urine sample #E306895 taken from the horse "MONARCH 59", second (2nd) place finisher in the first (1st) race on June 22, 2019, at Arizona Downs was confirmed positive for the presence of the Class III foreign substance THEOPHYLLINE at a concentration of approximately 822 ng/ml.

A split sample was requested by Eloy Navarro and the split sample report from Analytical Toxicology Lab in Reynoldsburg, Ohio, confirmed the presence of the Class III foreign substance THEOPHYLLINE in blood/urine sample #E306895 taken from the horse "MONARCH 59", second (2nd) place finisher in the first (1st) race on June 22, 2019, at Arizona Downs.

The horse "MONARCH 59", second (2nd) place finisher in the first (1st) race on June 22, 2019, shall be disqualified and declared unplaced.

The official order of finish is as follows:

1. (#3) DETERMINED COWBOY
2. (#7) I ROLL LIKE THAT
3. (#1) POLLITICAL BLOOD
4. (#4) JESSAPOLITICAL GUY
5. (#2) LSGLORY
6. (#5) CORONADOS CHOICE

The horsemen's bookkeeper is hereby directed to make the necessary changes. This action does not alter the Pari- Mutuel results of the race in question.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by August 29, 2019, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning August 30, 2019, through and inclusive of February 26, 2020, and this matter is referred to the Director of the Arizona Department of Gaming/Racing Division with the recommendation that all licenses remain suspended until all requirements herein are satisfied.

During the term of his suspension Eloy Navarro is denied access to all grounds under the jurisdiction of the Arizona Department of Gaming/Racing Division. All horses owned and/or trained by the respondent are hereby denied entry for racing pending sale and/or transfer approved by the Board of Stewards.
