ARIZONA DOWNS: 2019 MEETING

Under the authority granted by Arizona Revised Statutes Title 5, Chapter 1, and Arizona Administrative Code Title 19, Chapter 2, the Board of Stewards at ARIZONA DOWNS, located at 10501 E. STATE ROUTE 89A, PRESCOTT VALLEY, held a hearing on Sunday, August 18, 2019 and issued the following Ruling:

Having been properly noticed for a formal hearing and having waived that right, Owner/Trainer Philip Daniel Hartman (ADG #11626) is hereby fined FIVE HUNDRED DOLLARS (\$500.00) plus 5% Race Horse Adoption Fund surcharge for a total of FIVE HUNDRED TWENTY FIVE DOLLARS (\$525.00) and suspended FIFTEEN CALENDAR DAYS, (15) (August 19, 2019, through September 2, 2019, inclusive), after receipt of an affidavit from Industrial Laboratories indicating blood/urine sample #E307062 taken from the horse "TIZ THE STORM", First (1st) place finisher in the fourth (4th) race on July 28, 2019, at Arizona Downs was confirmed positive for the presence of the Class III foreign substance CANNABIDIOL at a concentration of approximately 327 pg/ml.

The horse "TIZ THE STORM", First (1st) place finisher in the fourth (4th) race on July 28, 2019, shall be disqualified and declared unplaced.

The horsemen's bookkeeper is hereby directed to make the necessary changes. This action does not alter the Pari- Mutuel results of the race in question.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by August 29, 2019, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning August 30, 2019, through and inclusive of February 26, 2020, and this matter is referred to the Director of the Arizona Department of Gaming/Racing Division with the recommendation that all licenses remain suspended until all requirements herein are satisfied.

During the term of his suspension Philip Daniel Hartman is denied access to all grounds under the jurisdiction of the Arizona Department of Gaming/Racing Division. All horses owned and/or trained by the respondent are hereby denied entry for racing pending sale and/or transfer approved by the Board of Stewards.
