STEWARDS' RULING**

ARIZONA DOWNS: 2018 MEETING

Under the authority granted by Arizona Revised Statutes Title 5, Chapter 1, and Arizona Administrative Code Title 19, Chapter 2, the Board of Stewards at ARIZONA DOWNS, located at 10501 E. STATE ROUTE 89A, PRESCOTT VALLEY, held a hearing on Saturday, August 31, 2019 and issued the following Ruling:

Having been properly noticed for a formal hearing and having waived that right, Trainer Heraclio Carrasco Botello (ADG #11491) is hereby fined FIVE HUNDRED DOLLARS (\$500.00) plus 5% Race Horse Adoption Fund surcharge for a total of FIVE HUNDRED TWENTY FIVE DOLLARS (\$525.00) and suspended FIFTEEN CALENDAR DAYS, (15) (October 12, 2019, through October 26, 2019, inclusive), after receipt of an affidavit from Industrial Laboratories indicating urine sample #E307119 taken from the horse "STONE CASH", first (1st) place finisher in the first (1st) race on August 17, 2019, at Arizona Downs was confirmed positive for the presence of the Class III foreign substance CLENBUTEROL at a concentration of approximately 52.5 pg/ml.

The horse "STONE CASH", first (1st) place finisher in the first (1st) race on August 17, 2019, shall be disqualified and declared unplaced. Additionally "STONE CASH", shall be placed on the Stewards List from August 31, 2019 (date of the initial report of positive findings) through and inclusive of October 30, 2019, (60 days) and must be retested (negative sample) for foreign substances prior to removal from the Stewards List.

The official order of finish is as follows:

1. (#6) CRISTO CARTEL
2. (#1) EL TIPASSO
3. (#4) DASHING KATT
4. (#2) STORM TREASURE

The horsemen's bookkeeper is hereby directed to make the necessary changes. This action does not alter the Pari- Mutuel results of the race in question.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by September 10, 2019, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning September 11, 2019, through and inclusive of March 20, 2020, and this matter is referred to the Director of the Arizona Department of Gaming/Racing Division with the recommendation that all licenses remain suspended until all requirements herein are satisfied.

During the term of his suspension Heraclio Carrasco Botello is denied access to all grounds under the jurisdiction of the Arizona Department of Gaming/Racing Division. All horses owned and/or trained by the respondent are hereby denied entry for racing pending sale and/or transfer approved by the Board of Stewards.
