ARIZONA DOWNS: 2018 MEETING

Under the authority granted by Arizona Revised Statutes Title 5, Chapter 1, and Arizona Administrative Code Title 19, Chapter 2, the Board of Stewards at ARIZONA DOWNS, located at 10501 E. STATE ROUTE 89A, PRESCOTT VALLEY, held a hearing on Saturday, August 31, 2019 and issued the following Ruling:

Having been properly noticed for a formal hearing and having waived that right, Owner/Trainer Daniel M Hernandez (ADG # 10123) is hereby fined ONE HUNDRED DOLLARS (\$100.00) plus 5% Race Horse Adoption Fund surcharge for a total of ONE HUNDRED AND FIVE DOLLARS (\$105.00) for failing to honor the entry of the horse "RY GUY" for the fifth race on August 31, 2019, resulting in a late scratch.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by September 10, 2019, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning September 11, 2019, through and inclusive of March 9, 2020, and this matter is referred to the Director of the Arizona Department of Racing with the recommendation that all licenses remain suspended until all requirements herein are satisfied.

The above described matter constitutes a violation in accordance with:

A.A.C. R19-2-106(C); A.A.C. R19-2-109(2); A.A.C. R19-2-121(E)
