

**ARIZONA DEPARTMENT OF RACING
STEWARDS' RULING**

RILLITO: 2019 MEETING

Under the authority granted by Arizona Revised Statutes Title 5, Chapter 1, and Arizona Administrative Code Title 19, Chapter 2, the Board of Stewards at RILLITO, located at 4502 N. 1st Street, Tucson, held a hearing on Friday, April 26, 2019 and issued the following Ruling:

Having been properly notified of a formal hearing, and having waived that right on March 26, 2019, Trainer George Sainz (ADG #20083), is hereby fined FIVE HUNDRED DOLLARS (\$500.00) plus 5% Race Horse Adoption Fund surcharge for a total of FIVE HUNDRED TWENTY FIVE DOLLARS (\$525.00) and suspended FIFTEEN (15) calendar days (March 26, 2019, through April 10, 2019 inclusive) following receipt of a report from Industrial Laboratories indicating blood sample #E225197 taken from the horse "FAST FOOT FLOOZIE" SEVENTH place finisher of the sixth race on March 10, 2019, was confirmed positive for the presence of the Class IV foreign substance HYDROCHLOROTHIAZIDE confirmed in BLOOD (3.30 ng/mL).

The horse "FAST FOOT FLOOZIE" seventh place finisher of the sixth race on March 10, 2019, is hereby disqualified and declared unplaced. The revised order of finish is as follows:

1st #4 GOLD MEDAL SPLASH	5th #8 YN INGENIERO
2nd #1 PAKEA JR	6th #5 KATIES MIRACLE
3rd #2 AZOOM CORONA	7th #6 RED DIABLO VICTORY
4th #3 SHAKIN CASH	

The horsemen's bookkeeper is directed to make the necessary changes. This revision of the order of finish does not alter the Pari-Mutuel results of the race in question.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by April 5, 2019, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning April 6, 2019 through and inclusive of October 3, 2019, and this matter is referred to the Director of the Arizona Department of Racing with the recommendation that all licenses remain suspended until all requirements are satisfied.

During the term of his suspension George Sainz is denied access to all grounds under the jurisdiction of the Arizona Department of Gaming/Racing Division. All horses owned and/or trained by the respondent are hereby denied entry for racing pending sale and/or transfer approved by the Board of Stewards.
