Jockey Scott Stevens aboard **#3 Ride Hard Kowboy** also lodged an objection against **#1 Buymeabond** and **#4 Rate For Me** alleging interference in late stretch. After reviewing the videos and taking testimony from the riders involved, the stewards determined that **#1 Buymeabond** did drift in near the wire and **#4 Rate For Me** did drift out near the wire with the actions of both horses putting **#3 Ride Hard Kowboy** in tight quarters and causing the jockey of **#3 Ride Hard Kowboy** to check sharply, however **#3 Ride Hard Kowboy** was not cost a better placing, therefore the stewards did not make any change to the original order of finish. The official order of finish is as follows: 1-4-3-8-9-6-7. Jockeys Francisco Arrieta and Andrew Ramgeet were required to appear before the board of stewards for a film review.
