**Significant Incidents /Matters:**

**Race 1: STEWARD INQUIRY/JOCKEY OBJECTION/DQ:** Following the running of the race the stewards posted the inquiry sign due to an incident down the stretch involving second place finisher **#6 Jt Scoremesomecash**, ridden by Luis Valenzuela, fourth place finisher **#7 Pakea Jr.**, ridden by Kevin Carbajal, and tenth place finisher **#8 Redneck Woman**, ridden by Emilio Tapia. There was also a jockey objection received from Kevin Carbajal, the rider of **#7 Pakea Jr.**, against **#6 Jt Scoremesomecash** alleging interference down the stretch. After reviewing the videos and taking testimony from the riders involved the stewards determined that **#6 Jt Scoremesomecash** bore out badly shortly after the start causing a chain reaction of events in which three outside horses had to steady including **#7 Pakea Jr.**, **#8 Redneck Woman** and **#9 Stel Saving**, ridden by Juan Ramirez. The stewards decided the incident cost **#7 Pakea Jr.**, **#8 Redneck Woman** and **#9 Stel Saving** the opportunity of better placings as all three horses had their chances compromised by the chain reaction. **#6 Jt Scoremesomecash** was disqualified from second place to last place. The original order of finish of 2-**6**-1-7-5-9-4-10-3-8 was changed to 2-1-7-5-9-4-10-3-8-**6**.

**Race 2: STEWARD INQUIRY/NO CHANGE:** Following the running of the race the stewards posted the inquiry sign due to an incident at the start of the race in which #**10 El Tipasso**, ridden by Juan Ramirez, did not leave the starting gate after the gates opened. After reviewing the videos and taking testimony from starter Denny Hall and jockey Juan Ramirez, the stewards determined the starting gate of #**10 El Tipasso** opened in unison with the rest of the field and the assistant starter released the horse properly. The horse was given the opportunity of a fair start and therefore the stewards did not make any change to the original order of finish. The official order of finish is as follows: 5-3-4-1-7-6-8-2-9-(10-DNF).

**Race 3: STEWARD INQUIRY/DQ:** Following the running of the race the stewards posted the inquiry sign due to an incident down the stretch involving second place finisher #**10 One Spicy Eagle** ridden by Andres Osuna and fourth place finisher #**9 Askin For Trouble**, ridden by David Reyes-Frisby. After reviewing the videos and taking testimony from the riders involved the stewards determined that #**10 One Spicy Eagle** came in under strong right hand whip near the wire causing the jockey of #**9 Askin For Trouble** to alter course and check near the wire. The stewards decision was to disqualify #**10 One Spicy Eagle** from second place to fourth place for costing #**9 Askin For Trouble** a better placing as he was only beaten a nose for third in this 100 yard dash. The original order of finish of 2-**10**-1-9-4-3-6-5-7-8 was changed to 2-1-9-**10**-4-3-6-5-7-8.
