Significant Incidents /Matters:

Race 1: STEWARDS INQUIRY/NO CHANGE: Following the running of the race the stewards posted the inquiry sign due to an incident near the three eighths pole involving first place finisher **#3 Cant Do The Danse**, ridden by Daniel Aguilar, second place finisher **#4 Timberfaller**, ridden by Martin Bourdieu, and third place finisher **#6 Mayday Malone**, ridden by Karlo Lopez. After reviewing the videos and taking testimony from the riders involved the stewards determined that third place finisher **#6 Mayday Malone** initiated events by drifting towards the inside leaving the gate, causing **#4 Timberfaller** to also drift over which put **#3 Cant Do The Danse** in tight quarters near the three eighths pole causing him to clip the heels of sixth place finisher **#2 Beat Down Bully**, ridden by Michael Ybarra and stumble. However **#3 Cant Do The Danse** went on to win the race and **#4 Timberfaller** finished second thus the stewards decision was that no change be made to the order of finish. The official order of finish is as follows: 3-4-6-1-5-2. Jockeys Martin Bourdieu and Karlo Lopez were asked to appear before the board of stewards for film review.

Race 4: **#1 Toy's Party** pulled up near the sixteenth pole and was vanned off.

Race 6: JOCKEY OBJECTION/NO CHANGE: Following the running of the race, Andrew Ramgeet, the rider of second place finisher **#10 Game Star**, lodged an objection against first place finisher **#11 Hipplepotomus**, ridden by Rigo Sarmiento, alleging interference at the start of the race. After reviewing the videos and taking testimony from the riders involved, the stewards determined that **#11 Hipplepotomus** did come in slightly shortly after the start of the race bumping with **#10 Game Star**, however, the stewards decision was that the minor bumping incident did not cost **#10 Game Star** a better finishing position, therefore the stewards did not make any change to the original order of finish. The official order of finish is as follows: 11-10-5-7-3-4-2-6-8-1-9. Jockey Rigo Sarmiento was asked to appear before the board of stewards for film review.

Race 2: STEWARDS INQUIRY/SPILL/DQ: Following the running of the race the stewards posted the inquiry sign due to an incident mid-stretch involving third place finisher **#1 Matts Corona**, ridden by Luis Yescas, fourth place finisher **#3 Mr EI R 15**, ridden by Juan Ramirez, and **#2 Starz Decoy** who lost the rider and was being ridden by Martin Bourdieu. After reviewing the videos and taking testimony from the riders involved, the stewards determined that **#1 Matts Corona** came out shortly after the start making contact with **#2 Starz Decoy** pushing him outwards towards **#3 Mr EI R 15**. **#1 Matts Corona** continued to drift out slightly from the inside putting **#2 Starz Decoy** in tight quarters while **#3 Mr EI R 15** came in slightly. **#2 Starz Decoy** clipped the heels of **#1 Matts Corona**, stumbled and lost the rider. For interference in the stretch the stewards disqualified **#1 Matts Corona** from third place and declared him unplaced. The original order of finish of 5-8-1-3-6-7-(2 DNF) was changed to 5-8-3-6-7-(2-DNF)-(**1 Unplaced**).

Race 1: JOCKEY OBJECTION/NO CHANGE: Following the running of the race, Martin Osuna, the rider of second place finisher **#4 Unregulated Cash**, lodged an objection against first place finisher **#7 Higher Icon**, ridden by Ernie Aispuro, alleging interference near the finish line. After reviewing the videos and taking testimony from the riders involved the stewards determined **#7 Higher Icon** did drift in making contact with **#4 Unregulated Cash** near the wire, however it was the stewards decision that it did not cost **#4 Unregulated Cash** a better placing, therefore the stewards did not make any change to the original order of finish. The official order of finish is as follows: 7-4-3-1-2-8-6-5. Jockey Ernie Aispuro was noticed to appear before the board of stewards for a film review.

Race 3: #5 Bp Southern Hero was announced to the public as an owner change to Jose Gallardo.

STEWARDS INQUIRY/DQ: Following the running of the race the stewards posted the inquiry sign due to an incident down the stretch involving seventh place finisher **#7 Discrete Glory**, ridden by Martin Osuna, eighth place finisher **#6 Beautiful Return**, ridden by Luis Yescas, and ninth place finisher **#5 Bp Southern Hero**, ridden by Emilio Tapia. After reviewing the videos and taking testimony from the riders involved the stewards determined that **#7 Discrete Glory** veered in sharply shortly after the start causing both **#6 Beautiful Return** and **#5 Bp Southern Hero** to be put in very tight quarters for several jumps compromising their chances. The stewards decision was to disqualify **#7 Discrete Glory** from seventh place to

ninth place for costing both #6 Beautiful Return and #5 Bp Southern Hero the opportunity of a better placing. The original order of finish of 3-2-9-4-1-8-~~Z~~-6-5 was changed to 3-2-9-4-1-8-6-5-~~Z~~.

TURF PARADISE RULING #18-19TP039

Having been properly noticed for a formal hearing and having appeared telephonically, Jockey Luis Rene Yescas (ADG #17900) is hereby suspended seven (7) racing days (December 1,2,3,4,5,8,9, 2018, inclusive) for failure to make sufficient effort to maintain a straight course in the stretch, thereby resulting in the disqualification of his mount, "MATTS CORONA", from third place to last in the second race on November 24, 2018. An aggravating factor considered in the penalty was that a spill was involved.

This suspension does not preclude Jockey Luis Rene Yescas from riding in designated races.
