TURF PARADISE RULING #18-19TP024

Having been properly noticed for a formal hearing and having waived that right on November 7, 2018, Trainer Marjorie Ann Cantrell (ADG #22364) is hereby fined ONE HUNDRED DOLLARS (\$100.00) plus 5% Race Horse Adoption Fund surcharge for a total of ONE HUNDRED AND FIVE (\$105.00) for being late to the paddock with the horse "Canada" for the 8th race on November 5, 2018 necessitating a late scratch.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by November 13, 2018, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning November 14, 2018 through and inclusive of May 13, 2018, and this matter is referred to the Director of the Arizona Department of Racing with the recommendation that all licenses remain suspended until all requirements herein are satisfied.

17, 2018 inclusive) for failing to maintain a straight course in the stretch aboard #7 "**PUNDY**" in the third race on November 5, 2018, causing interference to an inside horse. This suspension does not preclude Jockey Mckenzie King from riding in designated races.

Having been properly noticed for a formal hearing and having waived that right on November 7, 2018, Trainer Rudy Ybarra (ADG #12700) is hereby fined ONE HUNDRED DOLLARS (\$100.00) plus 5% Race Horse Adoption Fund surcharge for a total of ONE HUNDRED AND FIVE DOLLARS (\$105.00) for having missed Lasix with the horse "HEY EZ MONEY", resulting in a late scratch in the 3rd race on November 5, 2018.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by November 21, 2018, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning November 22, 2018 through and inclusive of May 21, 2019, and this matter is referred to the Director of the Arizona Department of Racing with the recommendation that all licenses remain suspended until all requirements are satisfied.

TURF PARADISE RULING #18-19TP029

Having been properly noticed for a formal hearing and having appeared on November 10, 2018, Owner/Trainer Robertino Diodoro (ADOR #10970) is hereby fined TWO THOUSAND DOLLARS (\$2,000.00) plus 5% Race Horse Adoption Fund surcharge for a total of TWO THOUSAND ONE HUNDRED DOLLARS (\$2,100.00) for using abusive and derogatory language and displaying an attitude of extraordinary disrespect directed towards a Racing Official (Track Veterinarian) within hearing range of state regulators and licensees on November 3, 2018, at Turf Paradise Race Course after the scratching of his horse in the post parade of the second race.

Aggravating factors taken into consideration when determining this penalty include the past record of Mr. Diodoro in the ARCI database. This is Mr. Diodoro's fifth Disorderly Conduct ruling since 2008.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by November 21, 2018, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning November 22, 2018 through and inclusive of May 21, 2019, and this matter is referred to the Director of the Arizona Department of Racing with the recommendation that all licenses remain suspended until all requirements herein are satisfied.

Jockey Denny Velazquez aboard #8 Bourque also lodged an objection against #3 Pappou alleging interference in late stretch. After reviewing the videos and taking testimony from the riders involved, the stewards determined that #3 Pappou did drift out in late stretch, however #8 Bourque was not cost a better placing, therefore the stewards did not make any change to the original order of finish. The official order of finish is as follows: 3-8-4-9-5-2-1-6-7.
