Race 4: STEWARDS INQUIRY/JOCKEY OBJECTION/DQ: Following the running of the race, Emilio Tapia, the rider of eighth place finisher **#4 Priceless Mr Jess**, lodged an objection against first place finisher **#3 Higher Icon**, ridden by Ernie Aispuro, alleging interference in the stretch. Upon further review the stewards also called for an inquiry

involving third place finisher **#1 One Spicy Eagle**, ridden by Luis Valenzuela, **#3 Higher Icon**, and **#4 Priceless Mr Jess**. After reviewing the videos and taking testimony from the riders involved the stewards determined that **#1 One Spicy Eagle** bore out badly from the inside shortly after the start initiating a chain reaction of events which caused several outside horses to alter course, including **#4 Priceless Mr Jess**. The stewards determined that the interference cost **#4 Priceless Mr Jess** the opportunity of a better placing and disqualified **#1 One Spicy Eagle** from third place and placed last. The original order of finish of 3-8-1-10-2-5-7-4 was changed to 3-8-10-2-5-7-4-1. Jockey Luis Valenzuela was noticed to appear before the board of stewards for a film review the following race day.
