Turf Paradise Ruling #18-19TP006

Having been properly noticed for a formal hearing and having waived that right on October 15, 2018, Owner/Trainer Pedro Urias-Soto (ADG #11503) is hereby fined TWO HUNDRED (\$200.00) plus 5% Race Horse Adoption Fund surcharge for a total of TWO HUNDRED AND TEN (\$210.00) for failing to show up to the paddock with the horse "OFF THE SCREEN", resulting in a late scratch in the 6th race on October 14, 2018.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by October 26, 2018, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning October 27, 2018 through and inclusive of April 24, 2019, and this matter is referred to the Director of the Arizona Department of Racing with the recommendation that all licenses remain suspended until all requirements herein are satisfied.

The above described matter constitutes a violation in accordance with:
A.A.C. R19-2-106(C); A.A.C. R19-2-111.; A.A.C. R19-2-113(A)(6)(18); A.A.C. R19-2-121.

Having been properly notified for a hearing, and having waived that right on October 16, 2018, Owner/Trainer Eloy Mendoza (ADG #10122) is hereby fined ONE HUNDRED DOLLARS (\$100.00) plus 5% Race Horse Adoption surcharge for a total of ONE HUNDRED AND FIVE DOLLARS (\$105.00), for failing to identify the horse ENJOY THE RUN as a gelding at the time of entry in the second race on October 14, 2018.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by October 26, 2018, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning October 27, 2018 through and inclusive of April 24, 2019, and this matter is referred to the Director of the Arizona Department of Racing with the recommendation that all licenses remain suspended until all requirements herein are satisfied.

The above described matter constitutes a violation in accordance with:

Turf Paradise Ruling #18-19TP009

Having been properly noticed for a formal hearing and having appeared on October 16, 2018, Jockey Michael Ray Ybarra (ADG #11084) is hereby suspended three (3) racing days (October 21, October 22, and October 27, 2018 inclusive) for failing to maintain a straight course in the stretch aboard #6 "WALK WITH JESS" in the first race on October 14, 2018, causing interference to an outside horse. This suspension does not preclude Jockey Michael Ray Ybarra from riding in designated races.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by October 30, 2018, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning October 31, 2018 through and inclusive of April 28, 2019, and this matter is referred to the Director of the Arizona Department of Racing with the recommendation that all licenses remain suspended until all requirements herein are satisfied.
