**TURF PARADISE RULING #18-19TP012**

Having been properly notified for a hearing, and having waived that right on October 29, 2018, Owner/Trainer Juan Figueroa (ADG #10089) is hereby fined ONE HUNDRED DOLLARS (\$100.00) plus 5% Race Horse Adoption surcharge for a total of ONE HUNDRED AND FIVE DOLLARS (\$105.00), for failing to identify the horse KICKIN STOLI as a gelding at the time of entry in the first race on October 28, 2018.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by November 8, 2018, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning November 9, 2018 through and inclusive of May 8, 2019, and this matter is referred to the Director of the Arizona Department of Racing with the recommendation that all licenses remain suspended until all requirements herein are satisfied.

**Race 8: JOCKEY OBJECTION/TRAINER OBJECTION/NO CHANGE:** Following the running of the race, Ricardo Martinez, the rider of third place finisher **#5 Warren's Wesley**, and Alex J Torres-Casas, the trainer of third place finisher **#5 Warren's Wesley** lodged objections against first place finisher **#7 Awesome E K**, ridden by David G. Lopez, and second place finisher **#3 Curly's Waterfront**, ridden by Paul Francis, alleging interference down the backstretch and around the turn. After reviewing the videos and taking testimony from the riders involved the stewards determined that **#7 Awesome E K** did angle in slightly from the outside near the five eighths pole and **#5 Warren's Wesley** was racing in tight quarters. The videos were inconclusive of any further interference around the turn. The stewards decision was that the backside incident did not cost **#5 Warren's Wesley** a better finish position, therefore the stewards did not make any change to the original order of finish. The official order of finish is as follows: 7-3-5-8-1-2-6-4. Jockey David G. Lopez was asked to appear before the board of stewards for film review.
