Race 6: STEWARD INQUIRY/JOCKEY OBJECTION/NO CHANGE: Following the running of the race the stewards posted the inquiry sign to review the late stretch run of second place finisher **#5 Strongreach**, ridden by Alex Cruz, third place finisher **#3 Zambora**, ridden by Tracy Hebert, and fourth place finisher **#8 P T Bruiser**, ridden by Sahin Civaci. Jockey Tracy Hebert aboard **#3 Zambora** also lodged an objection against **#5 Strongreach**, alleging interference in late stretch. After reviewing the videos and taking testimony from the riders involved, the stewards determined that **#8 P T Bruiser**, who was on the inside, angled out sharply near the wire making contact with **#3 Zambora** who was between horses, and causing **#3 Zambora** to make contact with **#5 Strongreach**, who was on the outside. Both **#3 Zambora** and **#5 Strongreach** finished ahead of **#8 P T Bruiser**, who caused the interference, therefore the stewards did not make any change to the original order of finish. The official order of finish is as follows: 6-5-3-8-4-7-2.

Race 7: STEWARD INQUIRY/NO CHANGE: Following the running of the race the stewards posted the inquiry sign due to an incident shortly after the start of the race involving **#5 Kitten's Royal**, whose rider Francisco Monroy was unseated near the first turn. After reviewing the videos the stewards determined that several horses were racing in tight quarters when **#5 Kitten's Royal** appeared to clip the heels of **#7 Appellant**, who was also racing in tight quarters, and stumble and lose his rider. The stewards did not make any change to the original order of finish. The official order of finish is as follows: 1-2-6-3-4-9-7-8-10-(5-DNF).
