After reviewing the videos and taking testimony from the riders involved, the stewards determined that #11 Windward Storm did drift in late into the stretch causing #12 Privy to be put in tight quarters, however #12 Privy was tiring at the time and was not cost a better placing, therefore the stewards did not make any change to the original order of finish. The official order of finish is as follows: 3-2-6-11-4-1-8-12-7-9-5-10.
