TURF PARADISE RULING #18-19TP095

Having been properly noticed for a formal hearing and having waived that right on February 2, 2019, Owner/Trainer James Erwin Crotts (ADG #11456) is hereby fined ONE HUNDRED (\$100.00) plus 5% Race Horse Adoption Fund surcharge for a total of ONE HUNDRED AND FIVE DOLLARS (\$105.00) for failing to have the foal certificate papers on file for the horse "OUTLOOK" for the 3rd race on February 2, 2019, resulting in a late scratch.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by February 12, 2019, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning February 13, 2019, through and inclusive of August 12, 2019, and this matter is referred to the Director of the Arizona Department of Gaming/Racing Division with the recommendation that all licenses remain suspended until all requirements herein are satisfied.

The above described matter constitutes a violation in accordance with: A.A.C. R19-2-106(C); A.A.C. R19-2-111(A)(B); A.A.C. R19-2-113(B)(1); A.A.C. R19-2-121(E)

TURF PARADISE RULING #18-19TP096

Having been properly notified of a hearing and having appeared, Groom Steven H. Schmidt (ADG #15041) is hereby suspended for ONE HUNDRED AND TWENTY days, from January 15, 2019, through May 15, 2019 (Credited with sixteen days served after being summarily suspended on January 15, 2019) for refusing a human drug test as ordered by the Board of Stewards on January 15, 2019. In addition, the respondent must provide a negative urine sample and sign a drug testing agreement form prior to reinstatement.

During the term of his suspension, Groom Steven H. Schmidt is denied access to all grounds under the jurisdiction of the Arizona Department of Gaming/Racing Division.

TURF PARADISE RULING #18-19TP097

Having been properly noticed for a formal hearing and having appeared on February 2, 2019, Jockey Jose Francisco Arriola Serrano (ADG #21841) is hereby suspended three (3) racing days (February 9, February 10, and February 11, 2019, inclusive) for failing to maintain a straight course in the stretch aboard #2 "SCOTT FOR HER" in the eighth race on January 29, 2019, causing interference to an inside horse. This suspension does not preclude Jockey Jose Francisco Arriola Serrano from riding in designated races.
