**Race 8: STEWARDS INQUIRY/JOCKEY OBJECTION/NC:** Following the running of the race the stewards posted the inquiry sign due to an incident near the wire involving first place finisher **#5 Spooky Channel**, ridden by Denny Velazquez, second place finisher **#3 Gato Guapo**, ridden by Francisco Arrieta, and third place finisher **#2 Cleanup Hitter**, ridden by Andrew Ramgeet. Jockey Andrew Ramgeet aboard **#2 Cleanup Hitter** also lodged an objection against both **#5 Spooky Channel** and **#3 Gato Guapo** alleging interference near the wire. After reviewing the videos and taking testimony from the riders involved the stewards determined that **#5 Spooky Channel**, who was on the outside, kept a straight course, while **#3 Gato Guapo**, who was on the inside, came out near the wire putting **#2 Cleanup Hitter**, who was between horses, in tight quarters and causing his jockey to check. The stewards decision was that although **#2 Cleanup Hitter** was put in tight quarters the incident was very near the wire and **#2 Cleanup Hitter** had already attained the best placing he was going to get. Therefore the stewards did not make any change to the original order of finish. The official order of finish is as follows: 5-3-2-1-10-9-7-8-4.

**Race 4: STEWARDS INQUIRY/JOCKEY OBJECTION/TRAINER OBJECTION/DQ:** Following the running of the race the stewards posted the inquiry sign due to an incident nearing the finish line involving first place finisher #4 Sir Kowboy, ridden by Paul Francis and second place finisher #3 Maii, ridden by Rigo Sarmiento. Also, Rigo Sarmiento, the rider of second place finisher #3 Maii, lodged an objection against first place finisher #4 Sir Kowboy alleging interference in late stretch. In addition, Jose Luna Silva, the trainer of #3 Maii lodged an objection against #4 Sir Kowboy alleging interference in late stretch. After reviewing the videos and taking testimony from the riders involved the stewards determined that in late stretch #4 Sir Kowboy drifted in under right hand use of the riding crop making contact with and impeding #3 Maii and costing #3 Maii the opportunity of a better placing. Therefore, the stewards decision was to disqualify #4 Sir Kowboy from first position and place him second. The original order of finish of 4-3-8-6-1-9-5-2 was changed to 3-4-8-6-1-9-5-2.
