TURF PARADISE RULING #18-19TP098

Having been properly notified of a hearing and having appeared, Groom Roger Wilson Blan (ADG #11263) is hereby suspended for ONE HUNDRED AND TWENTY days, from January 23, 2019, through May 23, 2019 (Credited with thirteen days served after being summarily suspended on January 23, 2019) for refusing a search of his vehicle as ordered by the Board of Stewards on January 23, 2019 and for testing positive for methamphetamine and THC. In addition, the respondent must provide a negative urine sample and sign a drug testing agreement form prior to reinstatement.

During the term of his suspension, Groom Roger Wilson Blan is denied access to all grounds under the jurisdiction of the Arizona Department of Gaming/Racing Division.

The above described matter constitutes a violation in accordance with:
A.A.C. R19-2-106(C); A.A.C. R19-2-112; A.A.C. R19-2-121(E); A.R.S. 5.104(C);

TURF PARADISE RULING #18-19TP099

Having been properly notified for a hearing and having failed to appear, Owner Sergio Barcelo Cruz (ADG #24147) is hereby fined TWO HUNDRED DOLLARS (\$200.00) plus 5% Race Horse Adoption surcharge for a total of TWO HUNDRED AND TEN DOLLARS (\$210.00), for falsification of your license by failing to disclose his criminal record.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by February 16, 2019, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning February 17, 2019 through and inclusive of August 16, 2019, and this matter is referred to the Director of the Arizona Department of Racing with the recommendation that all licenses remain suspended until all requirements herein are satisfied.

A.A.C. R-19-2-106(B)(C); A.A.C. R-19-2-121(E); A.R.S. 5-104(B); A.R.S. 5-108(A)

TURF PARADISE RULING #18-19TP100

Having been properly notified of a hearing and having appeared, Outrider Jason M Perkins (ADG #15246) is hereby suspended for ONE HUNDRED AND TWENTY days, from January 23, 2019, through May 23, 2019 (Credited with thirteen days served after being summarily suspended on January 23, 2019) for refusing a field drug test as ordered by the Board of Stewards on January 23, 2019. In addition, the respondent must provide a negative urine sample and sign a drug testing agreement form prior to reinstatement.

During the term of his suspension, Outrider Jason M Perkins is denied access to all grounds under the jurisdiction of the Arizona Department of Gaming/Racing Division.

TURF PARADISE RULING #18-19TP101

Having been properly notified of a formal hearing and having appeared, Jockey Paul Anthony Francis (ADG #23835) is hereby suspended three (3) racing days (February 19, 20, 23, 2019, inclusive) for failure to make sufficient effort to maintain a straight course in the stretch, thereby resulting in the disqualification of his mount, "SIR KOWBOY", from first place to second place in the fourth race on February 11, 2019.

This suspension does not preclude Jockey Paul Anthony Francis from riding in designated races.

Race 4: TRAINER OBJECTION/JOCKEY HOLD/STRETCH/NC: Following the running of the race, Wade Rarick, the trainer of second place finisher #4 Colfear, ridden by Francisco Arrieta, lodged an objection against first place finisher #1 Thrasher, ridden by Leslie Mawing, alleging interference at the top of the stretch. Jockey Francisco Arrieta, rider of #4 Colfear also asked the board of stewards to put a hold on the race through communication with the outriders. After reviewing the videos and taking testimony from the riders involved the stewards determined that #1 Thrasher came in slightly at the top of the stretch while #4 Colfear came out slightly, thus both horses contributed to the incident. Therefore, the stewards did not make any change to the original order of finish. The official order of finish is as follows: 1-4-3-6-5-8-7-2.

#2 HE COULD was put on the stewards list for bearing out badly.

Race 6: STEWARD INQUIRY/JOCKEY OBJECTION/NC: Following the running of the race, the stewards posted the inquiry sign to review the stretch run of first place finisher #1 Big League, ridden by Francisco Arrieta, second place finisher #5 Fortified Effort, ridden by Andrew Ramgeet, and fourth place finisher #6 Blue Law, ridden by Daniel Vergara. Jockey Daniel Vergara aboard #6 Blue Law also lodged an objection against #1 Big League and #5 Fortified Effort alleging interference in the stretch. After reviewing the videos and taking testimony from the riders involved, the stewards determined that #5 Fortified Effort, who was on the outside, did drift in slightly mid-stretch while #1 Big League, who was on the inside, did drift out slightly mid-stretch causing the jockey of #6 Blue Law, who was between horses, to check briefly, however #6 Blue Law appeared to have running room at the time of the incident, therefore the stewards did not make any change to the original order of finish. The official order of finish is as follows: 1-5-4-6-2-3.

As a result, the stewards declared the horse a starter and made no change. The official order of finish is as follows: 3-6-4-7-1-2-5-9-8.
