Race 7: JOCKEY OBJECTION/BACKSTRETCH/NC: Following the running of the race, Karlo Lopez, the rider of eighth place finisher **#3 Magic Blast**, lodged an objection against fourth place finisher **#4 Takahiro's Dream**, ridden by Richard Lull, alleging interference down the backstretch. After reviewing the videos and taking testimony from the riders involved, the stewards determined that **#3 Magic Blast** was racing between **#4 Takahiro's Dream**, who was on the outside, and **#2 Gracie Belle**, ridden by Alex Cruz, who was on the inside. **#2 Gracie Belle** stepped out slightly while racing in tight quarters near the ½ mile pole making contact with **#3 Magic Blast** and causing that one to make contact with **#4 Takahiro's Dream** who was gradually coming over and caused **#3 Magic Blast** to check sharply between horses. The stewards decision was that the incident was caused by **#2 Gracie Belle** however **#2 Gracie Belle** finished behind **#3 Magic Blast**, therefore the stewards did not make any change to the original order of finish. The official order of finish is as follows: 9-8-1-4-5-7-6-3-2.

TURF PARADISE RULING #18-19TP102

Having been properly notified of a formal hearing and having waived that right, Jockey Chad Alan Lindsay (ADG #22253) is hereby fined ONE HUNDRED DOLLARS (\$100.00) plus 5% Race Horse Adoption surcharge for a total ONE HUNDRED AND FIVE DOLLARS AND (\$105.00) for failing to attend films on February 16, 2019, as instructed by the Board of Stewards.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by February 28, 2019, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning March 1, 2019 through and inclusive of August 28, 2019, and this matter is referred to the Director of the Arizona Department of Racing with the recommendation that all licenses remain suspended until all requirements herein are satisfied.

The above described matter constitutes a violation in accordance with: A.A.C. R-19-2-121(E)

TURF PARADISE RULING #18-19TP103

Having been properly notified of a formal hearing, and having waived that right on February 23, 2019, Trainer Eliazar Salas-Gomez (ADG #10913), is hereby fined SEVEN HUNDRED FIFTY DOLLARS (\$750.00) plus 5% Race Horse Adoption Fund surcharge for a total of SEVEN HUNDRED EIGHTY-SEVEN DOLLARS AND FIFTY CENTS (\$787.50) following receipt of a report from Industrial Laboratories indicating blood sample #E299058 taken from the horse "LODE THE GOLD" winner of the eighth race on February 5, 2019, was confirmed positive for the presence of the Class IV foreign substance TRIAMCINOLONE ACETONIDE (159 +/- 15 pg/mL).

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by March 5, 2019, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning March 6, 2019, through and inclusive of September 2, 2019, and this matter is referred to the Director of the Arizona Department of Gaming/Racing Division with the recommendation that all licenses remain suspended until all requirements herein are satisfied.
