TURF PARADISE RULING #18-19TP104

Owner/trainer Travis Mathew Wheeler (ADG #21559) appeared before the Board of Stewards on February 19, 2019, after having been properly notified of a formal hearing, and having appeared for said hearing based on an affidavit from Industrial Laboratories that confirmed the presence of the Class III foreign substance CLENBUTEROL (approximately 30.1 pg/mL) and the Class II foreign substance ZILPATEROL (approximately 207 pg/mL) in the blood sample #E298731 taken from the horse "ONE FAMOUS ICON", winner of the first race on January 13, 2019, at Turf Paradise Race Course. After presentation of the evidence and hearing testimony from the licensee, the Board of Stewards rule that there is insufficient proof that Travis Mathew Wheeler is responsible for the presence of the above listed foreign substances in the blood of "ONE FAMOUS ICON."

Based on the evidence received, the Board of Stewards further rule that presence of the foreign substances in the blood of "ONE FAMOUS ICON" is confirmed, and, under A.A.C. R19-2-121(E)(3)(g) and R19-2-120(Q), the horse "ONE FAMOUS ICON", winner of the first race on January 13, 2019, shall be disqualified and declared unplaced. Additionally "ONE FAMOUS ICON", shall be placed on the Stewards List until April 3, 2019, (60 days from the date he was put on the list (February 2, 2019)) and must be retested (negative sample) for foreign substances prior to removal from the Stewards List.

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by March 7, 2019, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning March 8, 2019, through and inclusive of September 4, 2019, and this matter is referred to the Director of the Arizona Department of Gaming/Racing Division with the recommendation that all licenses remain suspended until all requirements herein are satisfied.

Having been properly notified of a formal hearing, and having waived that right on February 24, 2019, Trainer Curt Ferguson (ADG #10239), is hereby fined SEVEN HUNDRED FIFTY DOLLARS (\$750.00) plus 5% Race Horse Adoption Fund surcharge for a total of SEVEN HUNDRED EIGHTY-SEVEN DOLLARS AND FIFTY CENTS (\$787.50) following receipt of a report from Industrial Laboratories indicating blood sample #E299064 taken from the horse "THIRTY SECONDS OUT" winner of the second race on February 6, 2019, was confirmed positive for the presence of the Class IV foreign substance TRIAMCINOLONE ACETONIDE (202 +/- 15 pg/mL).

The fine set forth above must be satisfied within ten days from the date of this order. If it is not paid by March 7, 2019, all licenses held by the respondent are automatically suspended for one hundred and eighty days beginning March 8, 2019, through and inclusive of September 4, 2019, and this matter is referred to the Director of the Arizona Department of Gaming/Racing Division with the recommendation that all licenses remain suspended until all requirements herein are satisfied.

Having been properly noticed for a formal hearing and having appeared Owner/Trainer Alex J. Torres-Casas (ADG #16244) is hereby fined TWO THOUSAND FIVE HUNDRED DOLLARS (\$2,500.00) plus 5% Race Horse Adoption Fund surcharge for a total of TWO THOUSAND SIX HUNDRED AND TWENTY FIVE DOLLARS (\$2,625.00) and suspended ONE HUNDRED AND EIGHTY CALENDAR DAYS, (180) (March 4, 2019, through August 31, 2019, inclusive), after receipt of an affidavit from Industrial Laboratories indicating blood sample #E298768 taken from the horse "WINDI'S MOMENT", third (3rd) place finisher in the first (1st) race on January 15, 2019, at Turf Paradise Race Course was confirmed positive for the presence of the Class I foreign substance STRYCHNINE at a concentration of approximately 145 pg/ml and was confirmed positive for presence of the Class II foreign substance CAFFEINE at a concentration of approximately 218 +/- 15 ng/mL.

After receipt of an affidavit from Industrial Laboratories indicating blood sample #E298784 taken from the horse "STRAIGHTCASH HOMIE", second (2nd) place finisher in the seventh (7th) race on January 16, 2019, at Turf Paradise Race Course was confirmed positive for the presence of the Class I foreign substance STRYCHNINE at a concentration of approximately 182 pg/ml and was confirmed positive for presence of the Class II foreign substance CAFFEINE at a concentration of approximately 175 +/- 15 ng/mL.

After receipt of an affidavit from Industrial Laboratories indicating blood sample #E298854 taken from the horse "GIRO CANDITO", in the eighth (8th) race on January 23, 2019, at Turf Paradise Race Course was confirmed positive for the presence of the Class I foreign substance STRYCHNINE at a concentration of approximately 270 pg/ml and was confirmed positive for presence of the Class II foreign substance CAFFEINE at a concentration of approximately 195 +/- 15 ng/mL.

After receipt of an affidavit from Industrial Laboratories indicating blood sample #E298934 taken from the horse "SS TAYLOR", in the eighth (8th) race on February 2, 2019, at Turf Paradise Race Course was confirmed positive for the presence of the Class II foreign substance CAFFEINE at a concentration of approximately 206 +/- 14 ng/mL.

The horse "WINDI'S MOMENT", winner of the first race on January 15, 2019, shall be disqualified and declared unplaced. Additionally "WINDI'S MOMENT", shall be placed on the Stewards List until May 4, 2019, (60 days) and must be retested (negative sample) for foreign substances prior to removal from the Stewards List.

Having been properly notified of a formal hearing, and having appeared, Owner/Trainer Travis Mathew Wheeler (ADG #21559) is hereby suspended THIRTY CALENDAR DAYS (March 6, 2019, thorough April 4, 2019, inclusive) and fined ONE THOUSANDS DOLLARS (\$1,000.00) plus 5% Horse Racing Adoption Fund for a total of ONE THOUSAND AND FIFTY DOLLARS (\$1,050.00) for allowing an entry in his name (ONE FAMOUS ICON), without the care, custody and control of the horse on January 13, 2019, (program training) which constitutes conduct detrimental to racing.

During the term of his suspension, Travis Mathew Wheeler is denied access to all grounds under the jurisdiction of Arizona Department of Gaming/Racing Division.

The fine set forth above must be satisfied within ten (10) days from the date of this order. Race 1: TRAINER OBJECTION/NC: Following the running of the race, Alex Torres-Casas, the trainer of third place finisher **#4 Raging Lady**, ridden by Alex Cruz, lodged an objection against the winner **#6 Something About You**, ridden by Chad Lindsay, alleging interference at the start of the race. After reviewing the videos and taking testimony from the riders involved, the stewards determined that **#6 Something About You** broke inwards sharply from the outside, however, **#4 Raging Lady** also broke inwards and several horses towards the inside were in tight quarters at the start of the race. The stewards decision was that the videos were not conclusive to place blame on **#6 Something About You** as on the pan shot she appeared to be clear, therefore the stewards did not make any change to the original order of finish. Significant Incidents /Matters:

Race 1: STEWARDS INQUIRY/START/NC: Following the running of the race the stewards posted the inquiry sign due to an incident at the start of the race in which third place finisher **#2 Caribbean Queen**, ridden by Israel Hernandez, broke slowly and trailed the field early.
