#### Significant Incidents /Matters:

**Race 1:** It was announced to the public **#10 SHES FIVE BAR** would not be wearing a flipping halter. The riders aboard **#3 YN INGENIERO** and **#9 EL TARASCO 727** both lost their riding crops shortly after leaving the starting gate.

**Race 2: STEWARDS INQUIRY/SPILL/START/NO CHANGE:** Following the running of the race the stewards posted the inquiry sign due to an incident at the start of the race involving **#4 To The Limits**, whose rider Jake Samuels was unseated shortly after the start. After reviewing the videos the stewards determined that **#4 To The Limits** stumbled of her own accord unseating her rider. This action was not caused by any other horse; therefore the stewards did not make any change to the original order of finish. The official order of finish is as follows: 3-1-5-6-2-(#4-DNF).

Race 6: There was a two (2) way shake for #7 STORMS A BREWN.

Race 7: TRAINER OBJECTION/FIRST TURN-route/NO CHANGE: Following the running of the race, Juan Pablo Silva, the trainer of fifth place finisher #7 Packy's Out, ridden by Alex Cruz, lodged an objection against third place finisher #2 Maggie's Guy, ridden by Daniel Vergara, alleging interference going into the first turn. After reviewing the videos and taking testimony from the riders involved, the stewards determined that going into the first turn #2 Maggie's Guy became rank to place and bore out behind horses, however #2 Maggie's Guy was clear of #7 Packy's Out at the time and did not cost #7 Packy's Out the opportunity of a better placing, therefore the stewards did not make any change to the original order of finish. The official order of finish is as follows: 9-5-2-6-7-8-3-4-1.

**Race 3: STEWARDS INQUIRY/STRETCH/MUTUAL INTERFERENCE/NO CHANGE:** Following the running of the race the stewards posted the inquiry sign to review the stretch run of first place finisher **#3 Jazz Night**, ridden by Israel Hernandez, and second place finisher **#7 Addysgoingmobile**, ridden by Denny Velazquez. After reviewing the videos and taking testimony from the riders involved the stewards determined that contact was made near the 1/16<sup>th</sup> pole and again near the wire, with **#3 Jazz Night** drifting out and **#7 Addysgoingmobile** drifting in. The stewards decision was that the contact was mutually caused by both horses therefore the stewards did not make any change to the original order of finish. The official order of finish is as follows: 3-7-4-6-2.

**Race 1: 2 JOCKEY OBJECTIONS/TURN/NO CHANGE**

Following the running of the race there were two jockey objections. McKenzie King, the rider of fourth place finisher **#2 End Zone Embrace**, and Emilio Tapia, the rider of sixth place finisher **#3 Bitatheaven** lodged objections against third place finisher **#4 Heliacal**, ridden by Allyssa Morales, alleging interference around the turn. After

reviewing the videos and taking testimony from the riders involved, the stewards determined that both **#2 End Zone Embrace** and **#3 Bitahaven** did check at different points in the turn, however, the films were inconclusive as to any interference that took place, therefore the stewards did not make any change to the original order of finish. The official order of finish is as follows: 6-5-4-2-7-3.

**Race 3: JOCKEY OBJECTION/TURN/NO CHANGE**

Following the running of the race Francisco Arrieta, the rider of the third place finisher **#2 Rosso's Gatto**, lodged an objection against second place finisher **#4 Princess Becky**, ridden by Alex Cruz, alleging interference around the turn. After reviewing the videos and taking testimony from the riders involved, the stewards determined that fourth place finisher **#5 Ruhay**, ridden by Daniel Vergara began bearing out in the turn and appeared to put **#2 Rosso's Gatto** in tight quarters between horses causing the jockey of **#2 Rosso's Gatto** to check, however **#2 Rosso's Gatto** went on to out finish **#5 Ruhay** and the films were inconclusive as to any interference that took place between **#4 Princess Becky** and **#2 Rosso's Gatto**, therefore the stewards did not make any change to the original order of finish. The official order of finish is as follows: 6-4-2-5-3-1.
